

**ORDER UNDER SECTION 7(1) OF THE RIGHT TO INFORMATION ACT, 2005.**

Shri Rajinder Singh, (Retired Deputy Commissioner), 53, Hardev Nagar, Kpt. Road, Jalandhar City-144002 has made an application dated 08.06.2014 addressed to the Chairman, Central Board of Excise & Customs, North Block, New Delhi-110001 underwhich the CPIO/Under Secretary of the Government of India has directed to provide the information related to point No.5 & 6. The said letter has been received in this office from the Office of Chief Commissioner of Central Excise, Ahmedabad Zone on 26.08.2014. The applicant is seeking information in respect of point No 5) Supply the information with details of the officers Directorate/Zone wise who have been denied their rightful entitlement to fixation of pay and arrears of pay and allowances with effect from the date of their promotion to the post of Deputy Commissioner (December 2006) after completion of four years of continuous service till 30.06.2009. 6) Supply the information about the details of amount retained by the Government with the efforts of the CBEC by way of denying the rightful entitlements of the Government servants.

2. The information, as above, sought by the applicant it is to say that no any Assistant Commissioner has been promoted as Deputy Commissioner vide Order 27/2011 dated 15.02.2011 and no Arrears of Pay & Allowances with effect from the date of their promotion to the post of Deputy Commissioner (December 2006) after completion of four years of continuous service till 30.06.2009 has been given.

3. If the applicant is aggrieved with the information supplied, an appeal against this decision may be preferred in terms of Section 19(1) of the Right to Information Act, 2005 to Shri Milind Gawai, Appellate Authority, Additional Commissioner, Central Excise, 2<sup>nd</sup> Floor, Customs House, Navrangpura, Ahmedabad within a period of 30 days from the receipt of the order.
