ORDER UNDER SECTION 7(1) OF THE RIGHT TO INFORMATION ACT, 2005.

Shri G.K. Jhala 3, Customs Colony, Race Course, Ring Road, Rajkot-360001 has made an application dated 21.08.2014 addressed to the CPIO, O/O The Chief Commissioner of Central Excise (Ahmedabad Zone), Central Excise Bhawan, Gujarat which was received by this office on 02.09.2014. The applicant is seeking point wise information:- 1) Please provide the guideline for postings of officers in SEZ. 2) Please specify the criteria i.e. eligibility, qualification, experience, ACR grading for selection of the officers for posting in SEZ 3) Please provide tenure of posting of officers posted in SEZ in your Zone. 4) Is there any provision to extend the tenure of posting in SEZ? If yes please specify procedure for extension of such period. 5) Please give the details of the officers who had overstayed at SEZ even after completion of the specified tenure. 6) Whether the proper procedure was followed for extension for specified period which was granted to a particular officer for the overstay at SEZ. 7) Is there any provision to initiate disciplinary action against the officer who have overstayed in SEZ without proper approval by the proper authority. If yes please provide the details of the provisions. 8) Please provide details of action initiated against any officers and his supervisory head.

2. The information sought above is not looked after by this office. In view of this, the required information is not available with this office.

3. If the applicant is aggrieved with the information supplied, an appeal against this decision may be preferred in terms of Section 19(1) of the Right to Information Act, 2005 to Shri Milind Gawai, Appellate Authority, Additional Commissioner, Central Excise, 2nd Floor, Customs House, Navrangpura, Ahmedabad within a period of 30 days from the receipt of the order.
