3. If the applicant is aggrieved with the information supplied, an appeal against this decision may be preferred in terms of Section 19(1) of the Right to Information Act, 2005 to Shri Milind Gawai, Appellate Authority, Additional Commissioner, Central Excise, 2nd Floor, Customs House, Navrangpura, Ahmedabad within a period of 30 days from the receipt of the order.
