2. The supply of data cabling and Networking Items for structured cabling for the office is also responsibility of the selected L1 bidder for this project.
3. The supply of Electrical cable required for connectivity from Main DB to systems is also responsibility of the Bidder
4. The Bidder shall be responsible for supply & installation of Racks, Jack Panels, Patch Panels, CAT6 Cables, Patch cords, Connectors, I/o Boxes, Face Plates, Ferule, Tie for all network components, PVC Casing Capping Regular and Flexible Pipe as per on site requirement.
